1. **FINANCES:** I understand it is necessary that parents pay tuition for the amount stated on the Fees and Financial information sheet. If regular tuition is missed, you will be assessed a \$25.00 missed payment fee through FACTS Tuition Management. Any account that is outstanding 60 days after due date may suspend the student until payment is brought up to date. I understand there are no refunds made on the Registration Fee, Student Resource Fee or other fees. Tuition refunds will only be made on accounts paid beyond the current month.

2. **ACADEMY ACTIVITIES:** I give my permission for my child to take part in and travel to and from, all Academy activities and Academy sponsored trips away from the Academy premises. I absolve the Academy from liability to me or my child because of any injury to my child at GCA or during any Academy activity. In case of emergency or serious illness, I request that GCA contact me first. If I am not available, please call our family physician. If the physician cannot be reached, the Academy has my permission to make whatever arrangements seem necessary for my child's treatment.

3. **DISCIPLINE:** I believe discipline is a necessary aspect of my child's education. I give permission for my child's Teacher and/or Principal to make and enforce classroom regulations in a manner consistent with Christian principles and outlined in the GCA Policy Handbook. I will see that my child respects and obeys the Academy staff and Academy standards, realizing that God has given parents the primary responsibility for raising children. I understand that I may be asked to take an active role at GCA, in disciplining my child. I agree to act with full cooperation and support in that role.

4. **PARENTAL COMMITMENT:** I agree that I will in no case complain to other parents, but will register only necessary complaints with the Teacher and/or the Administration of GCA. I pledge my full cooperation to support the Parent Teacher Fellowship and classroom activities as much as my schedule allows. I understand my responsibility to read the Parent & Student handbook and agree to abide by its established policies.

5. **SPIRITUAL and DOCTRINAL COMMITMENT:** I understand that the Faculty and Administration of GCA will seek to lead each student into a personal, vital, and maturing relationship with Jesus Christ.
